REDUCED DEPOSITS FOR 2020 VOYAGES

CRYSTAL CRUISES

Effective June 8, 2020, the reduced deposit is \$100 per guest for new Ocean voyages, regardless of length.

CRYSTAL RIVER & YACHT CRUISES

The reduced deposit is \$500 per guest for new River and Yacht voyages.

FINAL PAYMENT POLICY FOR 2020 BOOKINGS

CRYSTAL CRUISES

Effective June 8, 2020, Final Payment for existing and new Ocean bookings is 60 days prior to first service for voyages regardless of length.

CRYSTAL RIVER & YACHT CRUISES

Final Payment is 120 days prior to first service for new River and Yacht bookings regardless of voyage duration.

CANCELLATION POLICY FOR 2020 BOOKINGS

Effective June 8, 2020 and until further notice, Crystal has established a temporary cancellation policy to provide more flexibility for our guests traveling aboard our Ocean, River and Yacht experiences:

- receive a 100% Future Cruise Credit (FCC) for cruise monies paid
- Cancel up to 7 days prior to first service and Applicable to all bookings made on Ocean, River and Yacht
 - Future Cruise Credit (FCC) is redeemable on cruises through the end of 2023
